The individual meets ONE of the following criteria: (circle a, b, or c)</b> a) Has been terminated or laid off, or has received a notice of, termination or layoff, from employment because of any permanent closure of, or any substantial layoff at, a plant, facility, or enterprise. b) Is employed at a facility at which the employer has made a general announcement that such facility will close within 180 days. c) Is employed at a facility at which the employer has made a general statement that the facility will close.

Is <u>not</u> currently employed, and meets ONE of the following long-term unemployed criteria: (circle a, b, c, or d)</b> a) Has not been employed for at least the previous four weeks, <b>AND</b> Has actively looked for work during the previous four weeks, <b>AND</b> Is currently available for work, <b>AND</b> Has been unemployed for ( <b>check one</b> ): <input type="checkbox"/> 4-14 weeks <input type="checkbox"/> 15 or more weeks b) Has not been employed for the previous four weeks, <b>AND</b> Has or had a barrier to actively looking for work during the previous four weeks, <b>AND</b> Is currently available for work or will be available for work once the barrier is addressed. c) Has not been employed for at least 15 of the previous 26 weeks, <b>AND</b> Was employed for at least one day within the previous four weeks, <b>AND</b> Exited the last employment for reasons other than dismissed for misconduct, <b>AND</b> Is currently available for work. d) Has no work history, <b>AND</b> Is currently available for work.	<input type="checkbox"/> <b>6. The individual was self-employed (including employment as a farmer, rancher, or fisherman) but is unemployed because of general economic conditions in the community in which the individual resides or because of natural disasters.</b>

Was self-employed and became significantly underemployed because of the disaster and meets ONE of the following criteria: (circle a, b, or c)</b> a) Is highly skilled but is working a low-paying job. b) Is highly skilled but is working in a low-skill job. c) Is working part-time but would prefer to work full-time and whose underemployment represents the loss of at least 25% of their pre-disaster income.	<input type="checkbox"/> <b>7. Is a Displaced Homemaker who has been providing unpaid services to family members in the home and who has been dependent on the income of another family member but is no longer supported by that income and is unemployed or underemployed and is experiencing difficulty in obtaining or upgrading employment.</b>

An individual who has been terminated or laid off (or who has received a notice of termination or layoff employment), AND is eligible for or has exhausted entitlement to unemployment compensation (or has been employed for a duration sufficient to demonstrate attachment to the workforce, but is not eligible for unemployment compensation due to insufficient earnings or having performed services for an employer that were not covered under a state unemployment compensation law), AND is unlikely to return to a previous industry or occupation.</b>	<input type="checkbox"/> <b>8. Is the spouse of a member of the Armed Forces and who has experienced a loss of employment as a direct result of relocation to accommodate a permanent change in duty station of such member.</b>
	<input type="checkbox"/> <b>9. Is the dependent spouse of a member of the Armed Forces on active duty and is unemployed or underemployed and is experiencing difficulty in obtaining or upgrading employment.</b>
	<input type="checkbox"/> <b>10. Is a dependent spouse of a member of the Armed forces on active duty and whose family income is significantly reduced because of a deployment, a call or order to active duty, a permanent change of station, or the service-connected death or disability of the member and is unemployed or underemployed and is experiencing difficulty in obtaining or upgrading employment.</b>
